Regulation No. 69/2025/2026

of the Rector of the Magdalena Abakanowicz University of the Arts Poznan
of 18 March 2026

on tuition fees for English-language studies in the Landscape Design programme
at the Magdalena Abakanowicz University of the Arts Poznan
from the academic year 2026/2027

Based on Article 79(1)(3) of the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Laws of 2024, item 1571, consolidated text), the following is hereby ordered from the academic year 2026/2027:

§ 1

1. This regulation defines the conditions of payment for undertaking fee-based studies in English in the Landscape Design programme at the Magdalena Abakanowicz University of the Arts Poznan (hereinafter referred to as the University).
2. Students pay tuition fees for English-language studies in the Landscape Design programme at first-cycle level in the amount equivalent to EUR 3,400 per semester (EUR 6,800 per academic year).
3. In the case of repeating a semester or year of first-cycle studies due to unsatisfactory academic results, except for cases specified in paragraph 4, students pay a fee equivalent to EUR 1,125 per semester (EUR 2,250 per academic year).
4. In the case of repeating the diploma semester in first-cycle studies due to unsatisfactory academic results, as well as in the case of failure to obtain a passing grade in the diploma examination, students pay a fee equivalent to EUR 750 per semester.
5. The fee for conditional enrolment in the next semester or year of studies is calculated by multiplying the number of ECTS points of the conditionally credited course(s) by the value of one ECTS point. The value of one ECTS point is EUR 55. The fee is payable by 1 February and/or 15 October of the academic year concerned. Decisions regarding conditional course repetition are



made each time upon request of the interested student by the Dean of the Faculty. Failure to pay the fee within the specified deadline constitutes grounds for removal from the student register.

6. The fees referred to in this regulation are paid in EURO and should be transferred to the following bank account:

 7. The fees referred to in points 2–5 are payable by 15 October of the academic year concerned for the winter semester and by 1 February for the summer semester.
 8. Statutory interest is charged on late payments. In the case of arrears exceeding three months, the student shall be removed from the student register.
 9. The conditions and procedures for exemption from tuition fees for educational services are defined in Resolution No. 64/2020/2021 of the Senate of the Magdalena Abakanowicz University of the Arts in Poznań of 29 September 2021.
